Privately Owned and Operated Historic Churches

In recent weeks this column has mentioned some privately owned churches that are in various stages or restoration or reopening to host Masses once again. It's worth mentioning that some of America's most noteworthy and architecturally significant historic churches are in the hands of private owners or operators. In some cases a diocese has transferred ownership of the church to a layled nonprofit organization, while in other cases a lay organization takes responsibility for operating the church while the title remains in the name of the diocese.



St. Alphonsus Church in New Orleans was an Irish parish located across the street from a German parish, St. Mary's Assumption. The two parishes merged, and in 1990 the diocese, while retaining ownership, leased St. Alphonsus to the Friends of St. Alphonsus. The group lovingly restored the edifice to its pre-Vatican II condition, opens it up for visitation every Saturday, hosts concerts and on rare occasions Masses. Perhaps the most famous and successful privately-run church in the U.S. is the Shrine of St. Joseph in St. Louis, Missouri. Still owned by the archdiocese but long administered by the Friends of St. Joseph, the Shrine has been restored to a state of true beauty. The sanctuary lighting in particular makes the reredos and statuary stand out. For a while the Shrine even hosted weekly Tridentine Masses. The archdiocese in turn has rewarded the volunteers by

Very little is said publicly about the fact that St. Patrick Church and Rosary Shrine in Merlin, Ontario has been acquired by a lay organization.

Staffed by the Rosarian Fathers of Sri Lanka, it functions as a shrine
